

# **ELECTRICAL GEMS – ONGOING ‘NEW PRODUCTS’ GIVEAWAY 2026**

## **TERMS AND CONDITIONS**

### **1. How to Enter**

Information on how to enter and prizes form part of these Terms and Conditions. Entry into the Promotion (Promotion) is deemed acceptance of these Terms and Conditions. Headings in this document are included for ease of reference, and do not affect interpretation in any way.

1. The Promotion is a game of chance.
2. The Promoter is Gemcell Pty Ltd (ABN 30 053 992 966) (Promoter)

### **2. Duration**

All references to time in this document are a reference to AEDST on the date/s stated. The Promotion commences at 12:01am, Monday 5 January 2026 and closes at 11:59pm, Thursday, 31 December 2026 (Promotion Period).

Each individual prize will be offered on Facebook and Instagram. There may be numerous posts during the promotional period, with one prize or prize pack offered, per post.

The date of the post/s may vary. The entry window will be marked for the individual post in the caption of the applicable post, at the time of posting.

The entry time by the entrant will be determined to be the date the email sign up form is submitted and received into the system. Any entry received outside of the promotional period as mentioned on the individual post will be deemed invalid. Entries will only be entered into the applicable individual post entry period, based on the timestamp of entry when submitted, and will not be carried forward or back into previous or future post giveaways.

### **3. Eligibility to enter**

- (1) Subject to clauses 3(1), 3(2) and 3(3), entry in the Promotion is open only to any entrant that: (Eligible Entrant).
  - (a) resides in Australia.
  - (b) is aged 16 years or over at the time of entering.
  - (c) has an active Facebook and Instagram account.
  - (d) follows the Electrical Gems Facebook and Instagram Page. (if not already a follower of the Electrical Gems Facebook and Instagram Page they must ‘like/follow’ the page at the time of entry).
- (2) Directors, management, employees, and their immediate families of Gemcell Pty Ltd (ABN 30 053 992 966.), including Gemcell member companies, are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, child or stepchild (whether natural or by adoption), parent, step-parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step-sister or first cousin.

  - (i) 'like/follow' the page
  - (j) click the link as directed by the post to complete and submit their entry form within the specified time frame, specifying the name of the giveaway they are entering.
- (2) There is a limit of one entry per person, per giveaway post. If an entrant is found to have entered more than one time, the Promoter may deem all entries of the entrant to be invalid, in its sole discretion. The result is final, and no correspondence will be entered into.
  - (3) If an entrant is the winner of a prize, they are no longer eligible to enter the New Products giveaways for a period of six (6) months.
  - (4) The Promoter accepts no responsibility for late, lost or misdirected entries.

#### 5. Drawing of Winners

- (1) A winner will be drawn for each promotional post at the offices of Gemcell Pty Ltd (ABN 30 053 992 966) at 7/40, Brookhollow Avenue, Norwest NSW 2153, using a random number generator, within the next 10 business days following the conclusion of the entry period. A back up winner will be selected immediately following the draw of the winner and will be referred to if the winner's entry is deemed to be invalid. The result is final, and no correspondence will be entered into. In the case where a winner or entry is deemed to be invalid, the backup winner will be awarded the prize.
- (2) If a chosen entry is deemed not to comply with these Conditions of Entry, the non-complying entry will be discarded, and a new winner of the prize will be determined by selecting the next drawn entry (as determined by the Promoter in its sole discretion).

- (3) The winner will be notified by email, phone and/or through Facebook or Instagram within 10 business days of the prize draw.
- (4) The Promoter expressly reserves the right to resolve any discrepancies, disputes or otherwise unforeseen circumstances as it deems fit subject to state regulation and the Promoter's decision will be final and binding upon every person who enters. No correspondence will be entered into. The Promoter expressly reserves the right to change or alter these Terms and Conditions at any time.
- (5) The Promoter accepts no responsibility for incomplete, incorrectly submitted, delayed, misdirected or illegible submissions.
- (6) If this promotion is not capable of running as planned due to any reason, including unauthorised intervention, fraud, or any other causes beyond the control of the Promoter, which corrupt or affect the administration, security, fairness, integrity or proper conduct of this promotion, the Promoter reserves the right (subject to any applicable law) in its sole discretion to cancel the competition or to disqualify any individual who has tampered with the entry process.

The prize will be sent to the Gemcell Member branch specified by the entrant when completing the entry form. The entrant will be advised when the prize is ready for collection, and must collect the prize from the branch within a reasonable timeframe.
- (2) If any prize is unavailable, Gemcell, in its discretion, reserves the right to substitute the prize with a prize to the equal value and/or specification. The Prize is non-transferable, non-refundable, non-exchangeable, non-replaceable and nonredeemable for cash. The Prize cannot be re-sold. The Prize must be taken as offered. No modifications or exchanges will be possible. The Promoter accepts no responsibility for any variation in the value, performance or availability of any prize.
